# *Terms and Conditions*

---

By receiving a copy of this document and by booking a function at Sea View Golf Club you agree to, and are bound by, the following Terms and Conditions:

## **Tentative Bookings**

Tentative bookings will be held for a period of 7 days and will automatically be cancelled unless a deposit has been paid or an agreement has been made to extend the period.

## **Social Membership**

A social membership of \$25 is required to hold your function at Sea View Golf Club. To confirm the booking, a membership form must be completed.

## **Confirmation and Deposit**

Confirmation of your booking will be made by deposit and a completed booking form.

Deposit terms for this package is \$150. Upon clearance of the deposit your booking will be confirmed.

The remainder of your balance after the booking deposit is made will be required as 50% of the total booking to be paid 30 days prior to the event. 100% of the total booking must be paid 14 days prior to the event. The venue is under no obligation to proceed with any booking if a deposit or payment is not received.

## **Final Confirmation**

Final payment and confirmation of final numbers must be paid and confirmed 14 days prior to the function. All catering will be required to be paid for based on the final number given prior to the function.

## **Final Settlement of Account**

At the completion of your function a balance invoice will be generated. This invoice will be due within 7 days of the event. Payments can be made via cash, cheque, EFTPOS or direct bank transfer.

## **Cancellations Policy**

All cancellations must be made in writing to the functions manager. Any booking cancelled 60 days prior to the function will receive a full refund. Any booking cancelled within 30 days prior to the function will forfeit the deposit. Any cancellations within 14 days of the function will be charged 100% of function fees.

## **Function Day Equipment Request**

Any additional equipment that is requested on the function day will be charged. This includes tables, chairs, linen, cutlery, napkins, chair covers and so forth. Please enquire with our Functions Manager for a detailed price list.



## **Food and Beverage**

All functions requiring catering must confirm menus 14 days prior to the function. No food or beverage of any kind will be permitted to be brought into the venue unless by prior arrangement with the functions manager. Menus are subject to change due to availability of produce, any changes will be advised

## **Smoking**

Sea View Golf Club is a non-smoking venue and smoking is only permitted in the designated area.

## **Damage or Cleaning**

You are liable for any damage sustained to the venue or property of the Sea View Golf Club. Any damages to any part of the building or grounds will be the financial responsibility of the function organiser. General cleaning is included in the venue hire however additional charges may be payable for any cleaning deemed above and beyond what is reasonable.

## **Responsible Service of Alcohol and Juveniles**

Sea View Golf Club reserves the right to refuse service of alcohol to any person attending any function. This may result in eviction from the venue. Sea View Golf Club reserves the right to refuse entry for any guest for any reason. All guests under the age of 18 must be accompanied by their parent or legal guardian. All guests must produce a valid photograph ID upon request. All guests are expected to behave in an orderly and lawful manner.

## **Equipment, Decorations and Entertainment**

Any unauthorised use of Sea View Golf Club equipment may incur a charge. Any Sea View Golf Club equipment which is damaged, misused or removed will incur a charge.

If you are considering decorations please consult the functions manager prior to your function, any unauthorised decorations and subsequent removal or cleaning costs may incur a charge. Nothing is to be nailed, screwed, stapled or stuck to any surface or any other part of the building. Confetti, rice or glitter are not permitted anywhere within the building or grounds. Rose petals are permitted.

Approval by functions manager is required before booking any entertainment.

Sea View Golf Club accepts no responsibility for any damage or loss of any guests' property at any time for any reason. All belongings must be collected and removed from the venue at the conclusion of your function.



### **Dress regulations**

All guests at the Club are asked to respect the dress standard (smart casual) at all times. Denim, t-shirts and thongs are not permitted. This dress standard also applies to service providers, musicians etc. Most importantly, footwear must be worn at all times.

### **Other Conditions**

Sea View Golf Club reserves the right to reassign the function to another room and/or area if the booked space is not considered suitable due to guest numbers changing significantly, extreme weather conditions or club maintenance issues which may arise and are out of managements control

### **Termination of Functions**

Sea View Golf Club reserves the right to terminate any function at any time if:

1. You or your guests fail to comply with the Terms and Conditions set out here
2. You or your guests fail to comply with Sea View Golf Club's house policies or act unlawfully
3. An event which is beyond Sea View Golf Club's control prevents the event taking place or continuing to take place
